

# XS Baggage Dangerous Goods Declaration



If you are carrying any of the below items, you must declare it and speak to XS Baggage.

Some of the below items are allowed to be sent, but special paperwork is needed to be filled out before any booking is made. **Please, ask one of our staff if you are unsure.**

All freight is x-rayed by the Aviation Security Services before it is allowed to travel for security reason. Large fines are in place if any Dangerous Goods are found and not declared.
